- 1. Call meeting to Order: Mayor Seymore called the meeting to order at 4:00pm.
- 2. Prayer and Pledges: Councilmember Lange gave the invocation and led the pledges.
- **3. Executive Session:** Council Adjourned into Executive Session at 4:02 p.m. pursuant to Texas Government Code.

- **4.** Reconvene and take Action if needed from Executive Session: The City Council reconvened in open session at 5:27 p.m. Mayor Seymore stated that no action was taken.

 - a. Emergifire Agreement, Ordinance/Resolution to collect insurance on Fire Department services- Chief Cornutt and Secretary Gayoso reported this is a 3rd party billing company. When there are accidents Emergifire will bill the insurance company then pay the City. Councilman Lange discussed the 18 percent rate is high. Cornutt also explained the different companies

that offer this. The City processing the paperwork is more work than worth. Currently the City is not receiving any funds. Cornutt discussed the City can start supplementing some of the Fire department expenditures. The Emergifire Contract will be for one year. Councilman Gray moved to go forward with the agreement and resolution. Councilman Lange seconded the motion. The motion carried unanimously.

- c. Council Comments and Recommendations Interim Akins discussed the tax rate is less than the voter approval rate. August 5th was a recommendation for formal presentation to Council. Tax rate and Budget approval proposal was for August 19, 2024. Mayor Seymore proposed to put the tax rate vote on the next agenda. Chief Cornutt spoke about the line item on inspections and testing for the Fire Department. Cornutt requested the \$6500 budget be increased to \$9000. Mayor Seymore took note, requested Akins to adjust this line. Seymore also discussed the current year only \$3000 has been spent and is questioning if the budget needs to be increased or not. Chief Cornutt stated that it did due to increased testing. Mayor Seymore asked about the filled positions in the police department. They are to be funded. Councilman Lange brought up the discussion on health insurance and contributions on the City's behalf. Interim Akins has recommended not to react but to decide what the health benefit package should look like. Lange discussed the non raises in the past, the insurance is a benefit and helps make up for that. Councilman Gray asked about what families it would hurt not to cover the HSA. Secretary Gayoso discussed the differences between HSA and non-HSA. Gayoso included she will continue getting quotes every year for health insurance. Lange discussed having the employees get their own insurance and the benefits and lower cost out of pocket.

6. Adjourn: Councilmember Lange made a motion to adjourn. Councilmember Gray seconded the motion. The motion carried unanimously. The meeting was adjourned at 6:35 p.m.
